FACTS	WHAT DOES WORLD OMNI FINANCIAL CORP. (FOR ITSELF AND DOING BUSINESS AS SOUTHEAST TOYOTA FINANCE) DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. With respect to the Driving Investments Notes Program, this information can include: <ul style="list-style-type: none"> ▪ Social Security Number ▪ Contact information (e.g., name, email address, phone number, etc.) ▪ Account information ▪ Account balances ▪ Checking account information ▪ Transaction history ▪ Transfer instructions ▪ Income ▪ Assets
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons World Omni Financial Corp./Southeast Toyota Finance chooses to share in connection with the Driving Investments Notes Program; and whether you can limit this sharing.

How does World Omni/Southeast Toyota Finance protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>Our affiliates include financial companies such as CenterOne Financial Services LLC, and nonfinancial companies such as Jim Moran & Associates, Inc., JM Family Enterprises, Inc., JM Family Automotive LLC, Southeast Toyota Distributors, LLC and its subsidiaries, Home Franchise Concepts, LLC and its subsidiaries and Futura Title & Escrow LLC and its subsidiaries.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>Bank of New York Mellon, the processing agent of the Driving Investments Notes Program.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ▪ <i>Our joint marketing partners include consumer finance companies.</i>

Other important information
<p>California Residents:</p> <p>Unless you have given your express written consent, we will not share your personal information for our affiliates to market to you or for other non-marketing purposes, for nonaffiliates to market to you, or for joint marketing with other financial companies.</p>

Vermont Residents:

We will not disclose information about your credit worthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to non-affiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
